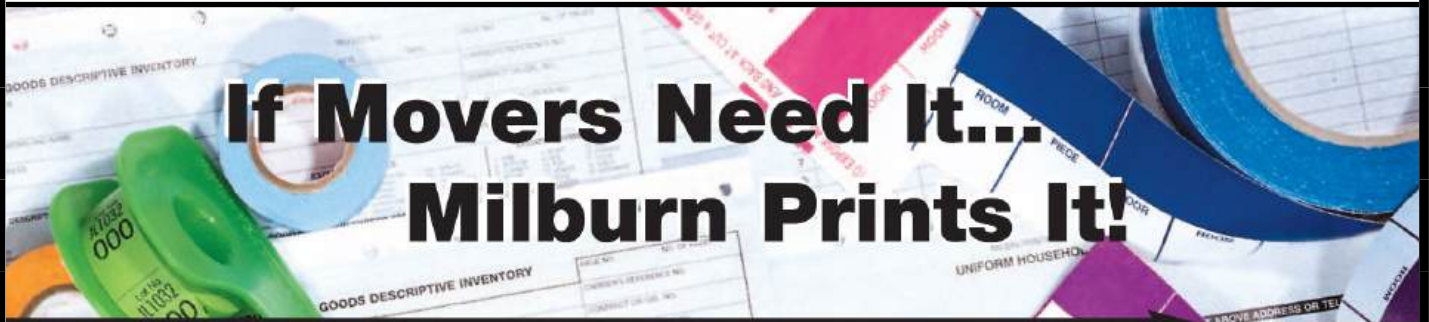

# Transportation Lawmakers Take Aim at Moving Industry Scams

## Bipartisan Bill Would Give State Agencies Federal Funds to Fight Fraud

A bipartisan bill that aims to protect consumers from falling victim to unscrupulous practices when moving goods and property was recently unveiled in Congress.

The Household Goods Shipping Consumer Protection

Act is designed to boost certain guidelines at the Federal Motor Carrier Safety Administration to help reassure individuals about consumer protections in place for moves made around the country.

"We cannot allow bad actors

in the shipping and moving industry to violate consumer trust and harm our nation's supply chain. Our bipartisan, bicameral legislation will give the Federal Motor Carrier Safety Administration the tools they need to hold these thieves accountable," said Sen. Deb Fischer (R-Neb.), a member of the freight policy committee, Jan. 30. Fischer is the bill's co-lead sponsor in her chamber.

"Bad actors are constantly developing new ways to defraud hardworking Americans, so it's critical we keep our legislation up to speed so we can protect our constituents from the latest scamming techniques," added co-lead sponsor Sen. Tammy Duckworth (D-Ill.), also on the Commerce Committee on freight policy.

Reintroducing the bill on the other side of the Capitol were Reps. Mike Ezell (R-Miss.) and Eleanor Holmes Norton (D-D.C.). The House lawmakers are senior members

of the Transportation and Infrastructure Committee. The pair had introduced an earlier version of the bill during the previous session of Congress, but that version did not reach the president's desk for enactment.

"The Household Goods Shipping Consumer Protection Act aims to tackle fraudulent practices in the moving and shipping industry that damage consumer trust and disrupt our national supply chain," Ezell said.

"Shipping fraud is a widespread issue that affects every corner of our nation. I will continue working to fight deceptive business practices by shipping companies," added Holmes Norton.

Specifically, the bill would equip FMCSA officials with authority to levy civil penalties against unregistered shippers. The agency also would be authorized to set requirements to ensure motor carriers, brokers and freight forwarders are operating legitimately in the marketplace. In targeting entities that threaten to hold customers' goods hostage until exorbitant bills are paid, the measure would allow state agencies to access federal funds to increase protections for household articles and personal possessions.

The bipartisan bill was referred to committees in the House and Senate. Votes on the bills have yet to be scheduled.

American Trucking Associations is among the transportation stakeholders backing the bill's introduction.

"When individuals and families begin the stressful process of relocating, the last thing they should have to worry about is being exploited by unscrupulous companies charging exorbitant rates and holding their household goods hostage. We commend Sens. Deb Fischer and Tammy Duckworth for tak-

ing action to help prevent consumers from becoming victims of moving fraud and protect the reputations of legitimate moving and storage companies and their hardworking employees," said ATA's Senior Vice President of Legislative Affairs Henry Hanscom and Moving and Storage Conference Executive Director Dan Hilton in a statement. "By creating additional tools to crack down on scammers, their legislation will help Americans have greater confidence that the moving professionals they entrust with their valuable possessions are experienced, honest and reliable."

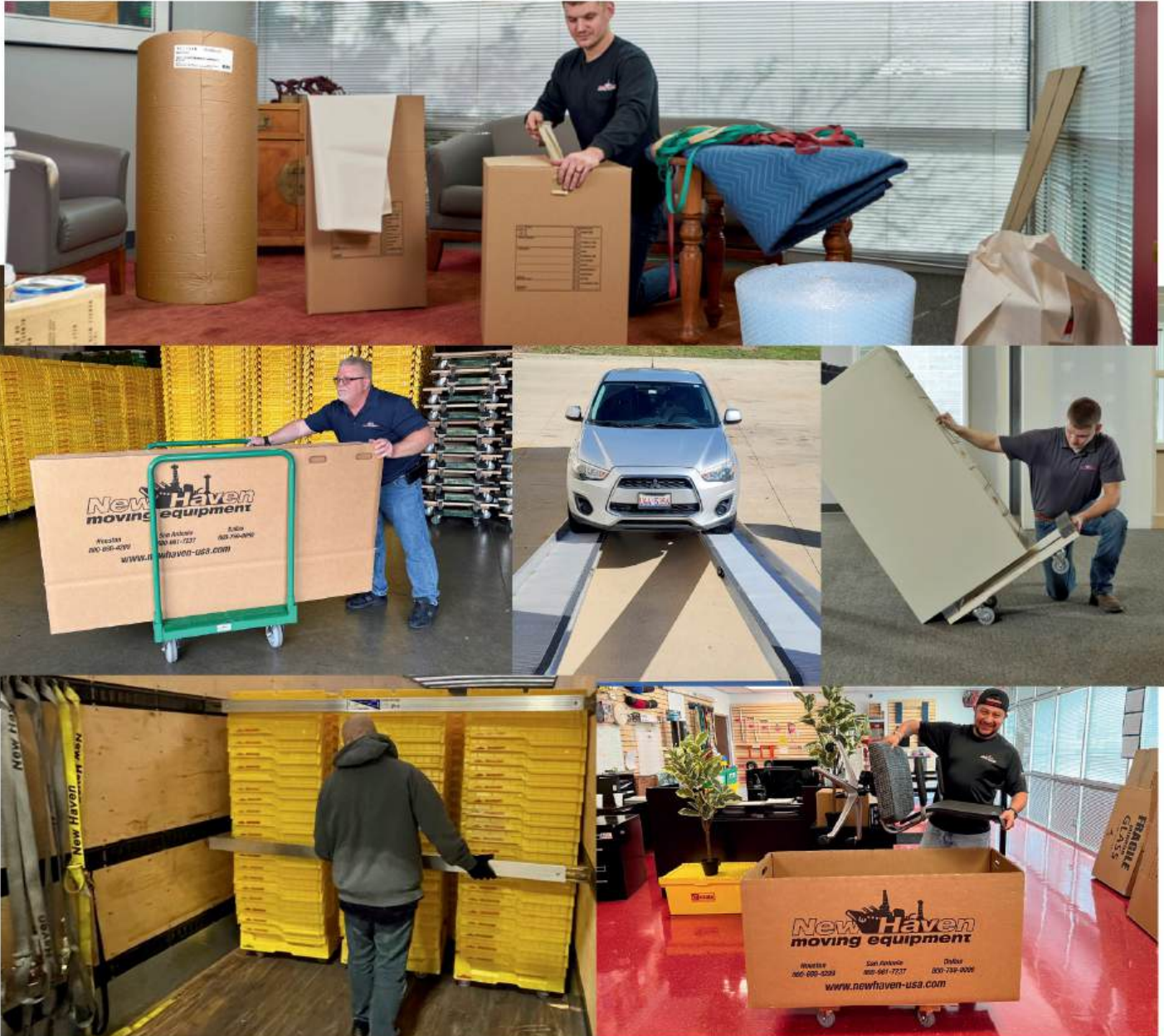

### **Broken Trust and Broken Promises: The GHC's Impact on Military Moves**

You know that feeling when you're excited to try something new, only to

have the outcome be disappointing? That's exactly how I feel about the Defense Department's sweeping overhaul of military moving services under the Global Household Goods Contract (GHC).

At first, I saw promise in the GHC. As a management executive for CG Moving in San Francisco, I've spent nearly two decades handling complex office and industrial moves. I was eager for the opportunity to expand our services and support military families. But after sitting through GHC town

halls and trade association events, my enthusiasm quickly faded. The company now managing all military moves under the contract offered little insight, few answers, and even less collaboration.

What became clear in these interactions is that the GHC prime contractor lacks respect for the expertise and experience of professional movers like me. Instead of working alongside long-time industry professionals to ensure a smooth transition, they appear dismissive of the very people who understand the logistical and personal complexities of military relocations.

Assessing, scheduling, packing, moving, storing, and delivering household shipments isn't just about logistics — it's about real-life challenges. We've navigated hurricane-force winds to deliver shipments, worked under blistering desert heat, and protected trucks from theft on steep San Francisco streets. And we do it gladly, especially for our nation's military families. These chal-

lenges aren't unique to us; they're daily realities for movers across the country and overseas.

Yet the company in charge of this transition has limited experience handling military moves and is failing to fully engage with the professionals who do. Alienating the workforce that has the trucks, the warehouses, and the institutional knowledge making these moves possible is a mistake that will have real consequences for military families.

Military families aren't just numbers on a spreadsheet or a case study in a PowerPoint presentation. They are real people who sacrifice so much for our country and deserve the dignity of a reliable, well-organized move. Unfortunately, we're already hearing from families who are experiencing late moving dates or no-shows that left them scrambling at the last minute.

Service members move, on average, every two and a half to three years. A smooth transition is critical for their families'

well-being and peace of mind. While there was certainly room for improvement under the previous system, why are we so quick to throw the baby out with the bath water? The majority of military moves have long been handled by experienced, hardworking movers who care about these families and understand the intricacies of military relocations — how to access bases, how to properly pack household goods for long-term storage, and how to provide the care these families deserve.

Trust is essential in any business. Sadly, the GHC prime contractor has damaged trust by failing to provide clear communication and guidance on how moving companies should comply with new federal compensation requirements under the Service Contract Act. The lack of transparency has left movers like me uncertain about our future under this contract.

The GHC could have been a chance to revolutionize military moving for the better. Instead of dismissing the industry's expertise, the contractor could have embraced a

# Military Surface Deployment and Distribution Command

**Subject:** REAL ID Full Enforcement  
Deadline May 8, 2025.

**Purpose:** To notify stakeholders of the May 8, 2025 implementation date for the REAL ID Enforcement.

**Be Advised:** On April 27, 2021, the Department of Homeland Security (DHS) announced it was extending the REAL ID full enforcement date by 19 months, from October 1, 2021, to May 3, 2023, and then again to May 7, 2025, due to circumstances resulting from the COVID-19 pandemic. Now that the deadline is approaching, DHS will not be extending the date.

**As a result, (card-based) enforcement of REAL ID for DoD base access will be in effect beginning May 8, 2025.**

Until May 7, 2025, DoD installations may continue to accept State (including DC and the territories) issued driver's licenses or non-driver's license ID cards from REAL ID-compliant States and territories for installation access purposes regardless of the presence of the "REAL ID star" on the card. The prohibition on accepting driver's licenses and non-driver's ID cards that bear markings along the lines of "Not Valid for Federal Purposes", "Federal Limits Apply", and/or "Not for Official Use", or other similar markings (known as "marked cards") is already in effect and will remain so.

After May 7, 2025 Real ID cards must be presented for DOD base access. Use of

REAL ID for DOD base access is to be enforced. If personnel do not have a REAL ID, then they will have to provide supplemental identification documents for base access. Supplemental identification documents are identified in DoDM 5200.08 Volume 3 (Physical Security Program: Access to DoD Installations): U.S. passport or passport card, Transportation Worker Identification Card (TWIC), Veteran Health Identification Card (VHIC), birth certificate, and social security card. These documents must supplement the non-REAL ID-compliant driver's license for access.

Transportation Service Providers (TSPs) should continue to check the Transportation Facilities Guide (TFG) for installation access information. Transportation personnel should ensure their TFG pages are updated with the most current access requirements, to include information on REAL ID requirements. Specific access-related questions should be directed to the points of contact listed in the TFG.

collaborative approach, learning from the professionals who actually do the work. Instead, we got vague presentations, confusing Excel spreadsheets, and empty promises.

Technology was touted as the solution to many moving inefficiencies, yet we waited endlessly for a promised demonstration that never came. When it finally did, it was just another slide deck. No amount of tech can replace skilled movers — you can't teleport furniture.

On top of this disastrous rollout, the GHC has coincided with a major reduction in reimbursement rates for Personally Procured Moves, where military families arrange their own moves. This seems like an effort to force families into a broken system by forcing them to choose between the flailing GHC

and the exorbitant costs of coordinating their own moves.

Professional movers deserve better. Military families deserve better. And the taxpayers deserve better. I urge elected officials at all levels to listen to the concerns of industry professionals like me and, more importantly, prioritize the needs of the brave men and women who serve our country. The GHC rollout has been riddled with missteps, and it's time to correct course before it does even more harm. Our military families deserve a moving system that works for them, not one that makes an already stressful transition even harder.
